# Fan Fiction and Fandom: A Case of Pakistani TV Drama "Mere Pas Tum Ho"

Abstract: This research paper focuses on the phenomenon of fan fiction in the context of the popular Pakistani TV Drama, "Mere Pas Tum Ho." Using Henry Jenkins' concept of participatory culture as a theoretical framework, this study aims to explore the themes existent in fan fiction based on the drama. The study employs a thematic analysis approach to examine a selection of fan fiction pieces based on said drama shared on fan fiction websites. Results indicate fan fiction based on "Mere Pas Tum Ho" is a reflection of the fans' engagement with and interpretation of the original work. Fan fiction pieces provide an alternative perspective on the characters of the drama. Fans use them as a platform to express their own ideas and opinions. The study shows fan fiction is a form of participatory culture, as fans actively engage with original work and use it as a springboard for their own creative output.

## Introduction

Fan fiction is a type of imaginative writing that uses established works of fiction or the media as its basis. Fans who create fan fiction take characters, settings, or plots from the original work of television dramas or movies. After gratification of the scenes, the fans craft new stories using those elements as portrayed in the dramas (Heljakka & Harviainen, 2019).

Over the years, fan fiction has gained popularity, with enthusiasts engaging in various activities such as writing fan fiction, producing fan art, and participating in online forums (Kelley & Composition, 2016).

Fan fiction has been around for centuries with its roots traced back to the 17th century when enthusiasts of Miguel de Cervantes' "Don Quixote" wrote their own adaptations of the tale. In the 20th century, fan fiction

continued to gain popularity, especially within the genres of science fiction and fantasy, as fans began to create their own narratives based on established works. The internet's emergence in the 1990s led to a surge in fan fiction, as fans could effortlessly share their creations with a broader audience online (Bennett, 2014; Warrier, 2018).

Recent research studies have concentrated on the correlation between fan fiction, original works of fiction and English fan fiction and its impact on the general public (Kriz, 2023). According to a study, fan fiction can be considered a form of literary criticism, fan fiction and its influence on language because fans use it to examine and assess the themes, characters, and plot of the source material. Likewise, another study maintained that fan fiction can be deemed as a type of participatory culture since fans actively engage with the original work and create their own stories based on it (Zhang & Mao, 2013).

Nevertheless, fan fiction has also faced criticism with some arguing that it constitutes copyright infringement and that fans are benefitting from the original work without permission. Moreover, some studies have expressed reservations about fan fiction while maintaining that it can misrepresent the characters, plot, scenes and themes of their work (Fathallah, 2017; Schwabach, 2016).

### Fan Fiction in Pakistan

Fan fiction has emerged as a recent phenomenon in Pakistan dating back to the early 2000s when internet usage was on the rise in Pakistan as well as across the globe. Such sort of writing involves the creation of stories utilizing characters and settings from popular works of fiction, and movies reinterpret the remixes of fictional events, or TV shows, which are then shared online by amateur writers (Kuhn & Westwell, 2012; Sauro, 2017).

The popularity of fan fiction in Pakistan can be traced back to online forums and communities, such as Orkut and Yahoo Groups, where young writers would gather to share their works and receive feedback from peers (Kim, Jeong, & Lee, 2010). With the passage of time, these communities transformed into dedicated websites and blogs, such as FanFiction.net, allowing Pakistani writers to share their works with an international audience (Price, 2017). The Harry Potter fan fiction community is one of the earliest examples of Pakistani fan fiction, which began to flourish in the mid-2000s, inspired by the popularity of the Harry Potter books and movies. Other popular fandoms in Pakistan include Twilight, Game of Thrones, and Marvel (Acevedo-Callejas, 2020).

In recent years, the Pakistani fan fiction community has continued to grow and diversify within the circles of writers exploring new fandoms such as K-pop and Pakistani television dramas. Pakistani writers now have dedicated online communities and forums, open source wikis, like Wattpad and Archive of Our Own that enable them to share their works globally (Lee, 2018; Mendes, 2023).

# The Objective of the Study

The research objectives of this research article have been set as:

- 1. To provide a literature review on fan fiction and its cultural relevance
- 2. To explore the emergence and growth of fan fiction in Pakistan
- 3. To conduct a thematic analysis of the popular Pakistani Television Drama "Mere Pas Tum Ho" and its fan fiction.

### Literature Review

The report offered a glimpse into the vibrant and dynamic world of Pakistani fandom culture.

The study explored the motivations behind fan fiction, highlighting the sense of empowerment, creativity, and the community it provides for fans. A study offered a historical overview of media fandom, discussing the different forms of fan expression and the impact of technology on fan culture (Irshad, Ahmad, & Review, 2019). #### Theoretical Framework

Reference-based on the content of the article, one possible theoretical framework that could be applied is Henry Jenkins' concept of participatory culture. # Methodology

The selection of fan fiction stories was chosen based on factors such as popularity, diversity of explored themes, and representation of different perspectives and interpretations of the original television series. The episodes from the original series were selected based on their relevance to the themes explored in the fan fiction stories. Popular fan fiction websites were used to read the extensions of Mere Pas Tum Ho Fan Fiction on the basis of their popularity and deduced the themes. A purposive sampling technique was used to get required sample. The researchers thoroughly watched all 23 episodes of *Mere Pas* Tum Ho and three famous fan fiction stories of "Mere Pas Tum Ho" from Wattpad (Canada), reviewit. pk and indiaforums.com for deducing the relevant themes for thematic analysis

## Pakistani Drama "Mere Pas Tum Ho"

"Mere Paas Tum Ho" is believed to be a highly popular Pakistani television drama that premiered in 2019 with Pakistani playwriter Khalil-ur-Rehman Qamar as the writer and Nadeem Baig, a famous Pakistani television actor in recent past, as the director of the play. The plot of the drama revolves around Danish, portrayed by Pakistani actor Humayun Saeed, and his wife Mehwish, played by Pakistani actress Ayeza Khan, and delves into the themes of love, betrayal, and societal expectations.

The drama's popularity can be attributed to its compelling storyline, the exceptional performances of the cast, and the relatable themes it explores, particularly those surrounding gender roles and societal norms. The portrayal of these issues resonated with the viewers and sparked widespread discussion and debate.

The drama also enjoyed a strong social media presence, with fans actively sharing

clips and discussing the plot online. Furthermore, the catchy title song, sung by Rahat Fateh Ali Khan, became a hit with the audiences, contributing to the show's overall success.

The popularity of "Mere Paas Tum Ho" was such that it set numerous records during its run, emerging as the most-watched drama in the history of Pakistani television. The final episode of the show had an estimated viewership of 25 million, cementing its place as a cultural phenomenon in Pakistan (Aljazeera Report, 2021).

Thematic Analysis of Original "Mere Pas Tum Ho"

"*Mere Pas Tum Ho*" is a popular Pakistani drama series that explores various themes, including:

**Love and Devotion:** The drama portrays the theme of love and devotion through the character of Danish, who remains committed to Mehwish despite her betrayal. For example, when Mehwish asks Danish, 'Forgive me'; he responds with the dialogue "*Mere Paas Tum Ho*" (I Own You), showing his unwavering love and devotion towards her.

**Betrayal and Consequences**: The drama explores the consequences of betrayal through the character of Mehwish, who cheats on Danish with her boss Shahwar and faces the repercussions of her actions. This is evident when Danish confronts Mehwish about her affair and decides to divorce her, leading to the devolution of their marriage.

Greed and Materialism: The drama highlights the negative impact of greed and materialism on relationships, as Mehwish's desire for a better life and her pursuit of wealth and status, lead her to betray her husband and consequently destroy her family life in the context of Pakistani culture. Masculinity and Patriarchy: The drama also portrays the theme of masculinity and patriarchy through the character of Shahwar, who uses his power and wealth to control Mehwish and manipulate her into having an

affair with him. This is evident when Shahwarpressurizes Mehwish into leaving Danish and convinces her that he can provide her with a better life.

Forgiveness and Redemption: The drama explores the theme of forgiveness and redemption through Danish's willingness to forgive Mehwish and work towards repairing their relationship. This is seen when Danish agrees to give Mehwish a second chance and decides to co-parent Roomi with her.

Self-worth and Self-Respect: The drama highlights the importance of self-worth and self-respect, especially for women, through Mehwish's journey towards realizing her mistakes and taking responsibility for her actions. This is evident when Mehwish decides to leave Shahwar and work towards rebuilding her relationship with Danish and Roomi.

Societal Pressures: The drama also depicts the theme of societal pressures, particularly related to gender roles and expectations. Mehwish's dissatisfaction with her life and her desire for more is rooted in societal pressure to conform to certain norms and expectations. This is evident when Mehwish's friends and family pressurize her to leave Danish for Shahwar, believing that he can provide her with a better life.

Overall, "Mere Pas Tum Ho" offers a complex exploration of human relationships and emotions, delving into themes such as love, betrayal, forgiveness, and societal pressure purely from the Pakistani perspective of the native culture of the country embedded in the Islamic way of life under the hegemonic approach of the patriarchal structure of society. The characters and their struggles serve as a reflection of larger societal issues, highlighting the importance of self-awareness, individuality, and the ability to break free from societal expectations.

# Thematic Analysis of the Fan Fiction "Mere Pas Tum Ho"

Additionally, fan fiction writers must respect the intellectual property of the original author and avoid using their work for commercial gain. While fan fiction can offer a creative outlet for writers and provide new perspectives on established works, there are legal and ethical considerations that must be taken into account. Fan fiction writers should be mindful of copyright infringement and how they represent the original work and its creators. By respecting these considerations, fan fiction can continue to be a valuable form of creative expression within the fandom community.
