Previous Study Regarding Cyber Bullying in Pakistan

A study was conducted in 2008 on Cyberbullying where a researcher tried to figure out that what exactly happed when a student gets bullied, he also tried to explore that why a cyber-bullied victim tried to hide the case, why he does not raise his voice. The data was collected from the student of 7th grade. Total number of populations of that research was 269. Researcher tried to figure out all these issues regarding Cyberbullying. The finding of the research was quite interesting because a larger number of students do nothing if they get bullied online. There were some other factors involved in the particular scenario. According to study, almost35% of people tried to help their best friend in these issues. The overall message of that particular research was that most of students hide, they feel insecure, and the fear of isolation and depression make them uncomfortable.

National and international scholars have notified that Cyberbullying is a severe psychological

problem. The deterrence of Cyberbullying is the main and the most important need of the society but for its prevention we need to make an effort to know that how it affects the mind of young students, why they suffer from this social negativity and how we can prevent it. The study was conducted from a student in Pakistan (Islamabad). Study focused on cyber victims, cyber bullies, and cyber bullies/ victim. The researcher conducted a cross sectional study in different universities of Islamabad and Rawalpindi in 2016. The researcher chose a sample of 508 participants in which 348 females and 160 males were being the part of the research. According to the findings of the research, 67% of students were being involved in Cyberbullying. Nearly 25% marked themselves as cyber victim. Just about 39% of students testified that they have been involved in dual role, both cyber victim and as cyber bullies. The pervasiveness rate of Cyberbullying is high between university students and persons engaged in Cyberbullying have a complex level of psychopathology and poor well-being in evaluation to those not involved.

In 2016 a regulation was passed by assembly that aided out in transporting the cyber offenders in the authority of law. A lawyer named Anousha Rehman clarified on manifold times how decent figure of lives were demolished due to misappropriation of digital media and that how vital it was to propagate this regulation. In spite of the regulation has been passed, community consciousness about this specific regulation is revealing. Rare private organizations identified the essential to conscious and release community (mainly females) from connected bullying. Digital Rights Foundation is one most important organization that mechanisms to generate community mindfulness, particularly females, on defensive their digital media id's and record their honest criticisms in contradiction of connected bullying. A study conducted in 2016, to find the statistics of females who were bullied connected. This investigation was done in seventeen main institution of higher education of Pakistan, in all the capital cities of the province. The answers were surprising as 34% of defendants (all females) self-confessed that they had confronted bullying on the digital while 55% approved that they distinguished about other females being bullied on internet. When requested persons who stated to Federal Investigative agency FIA for connected bullies, 47% replied that it was very obliging and their cases were correctly inspected. Though, 53% were of the view that reportage process wants to be more progressive and exact as it is not of much help. Astonishingly, 72% of cultured females didn't have information about the being of any regulation in contradiction of connected bullying. So according to the statistics the most common age was 22 and the most infrequent age was 17 and 31.
